# Baltimore City Association of the Deaf Board Meeting Minutes Saturday, April 25, 2020 Zoom

President Jacob Leffler called the meeting to order at 3:15 p.m.

## **President's Report:**

Jacob continued to work on the forms for the organization. He also reported about the issue with the current mayor, Mayor Bernard "Jack" Young told the interpreter to stop interpreting while the protesters were chanting. BCAD decided to send a letter and 24 hours later, the Mayor apologized. The Mayor explained at the press conference reasons why he asked the interpreter to stop interpreting. The Community is not satisfied with the apology and would like to see the actions and commitments from the Mayor.

From that, BCAD got a lot of media attention and reporters contacted BCAD for their inputs/opinions. Reporters from Baltimore Sun, Baltimore Brew, and the Daily Moth contacted BCAD. BCAD also sent a follow-up letter re-emphasizing the request to meet, deaf people have a representation on the Mayor's Commission on Disabilities and have annual sensitive and accessible training.

Several organizations such as the Baltimore Black Deaf Advocates, Howard County Association for the Deaf, and the Maryland Association of the Deaf sent the letter in support of BCAD.

BCAD heard back from the Office of Equity and Civil Rights and asked BCAD to have a meeting and wants to work with BCAD to improve accessibility for the City.
